

General Release

KNOW ALL BY THESE PRESENT, THAT I _____
as parent of my child(ren) _____, and in
consideration of the opportunity of my child to participate in the activities of Recreation Concepts, Inc.,
Mr. John Schmidt and Mrs. Jean Schmidt, including, but not limited to, any and all aquatic related
activities, the sufficiency of such consideration is hereby expressly acknowledged, do hereby for myself,
my child, and me assigns, and any and all other persons, firms, employers, corporations, associations, or
partnerships, do hereby release, acquit, and forever discharge, and agree to indemnify defend and hold
harmless, Recreation Concepts, Inc., its officers (including specifically Mr. and Mrs. John Schmidt in their
personal capacity), members, volunteers, faculty, assistants, advisors, attorneys, agents, servants,
successors, heirs, executors, administrators, assigns, Davis and Elkins College as swimming facility host,
and all other persons, firms, corporations, associations or partnerships of, and firm any and all claims,
actions, causes of actions, demands, rights, damages, costs, loss of wages, expenses, hospital and
medical expenses, loss of consortium, loss of service, and any compensation whatsoever, which the
undersigned or the undersigned's participating child, has now or will ever have as a result of travel to
and from such activities.

The undersigned expressly agrees to indemnify, defend and hold harmless any released party herein,
including any occupant or owner of any land or facility where aquatic or swimming activities are now or
will be held, from all claims arising out of the above referenced activities including any claim that may
have otherwise arising as a result of travel to and from such activities.

The undersigned acknowledges that the activities that the child is or will be engaging in, are potentially
dangerous and may involve numerous potential perils to the participant's life, health and safety
including, but not limited to, drowning, and injury from striking objects such as a diving board or the
bottom of the pool. It acknowledged that these perils can be fatal. The undersigned expressly
acknowledges that by allowing their child to engage in the above referenced aquatic activities, he or she
is voluntarily and knowingly assuming the risk of any possible accident, whether foreseeable or
unforeseeable, whether incidental or occurring as a result of such activities including the possibility of
injury or death of their child.

The undersigned further agrees to indemnify the above released parties and save them harmless from
any and all liability, loss, damage, claims or subrogation and expense, arising because of any injuries,
death or damages, related to any claims or subrogation and expense, arising because of any injuries,
death or damages, related to any claim of the child or a claim on the parents own behalf, and if
necessary in order to save the released parties harmless, to satisfy on their behalf any judgment against
the released parties, in any way arising out of the aforesaid activities, including but not limited to travel
to and from any activity.

The undersigned further declares and represents that no promise, inducement, or agreement not herein
expressed has been made to the undersigned and that this release contains the entire agreement
between the parties hereto, and that the terms of this release are contractual and are not a mere
recital. That it is the intent of this document to totally absolve and release Recreation Concepts, Inc, Mr.
and Mrs. John Schmidt personally, and the other releases parties herein, from any legal exposure of any

nature in any way related to the undersigned's child participating in the activities sponsored or organized by the released parties, including swimming and other aquatic activities.

I certify that I am not currently under the influence of alcohol and any other mood altering medication and fully understand this legal document.

The parties further agree that the laws of the state of West Virginia shall apply when construing this contract.

This document shall not cause or otherwise operate to release any insurance company of any released party from paying any claim that it would have otherwise have been responsible to pay, but for the existence of this document.
